I also focus on eliminating wasteful government spending, particularly preventing taxpayer dollars from being paid to abortion providers, like Planned Parenthood. I'm the principal sponsor of the Balanced Budget Amendment, which would require Congress to make the tough decisions required to actually balance the federal budget.
